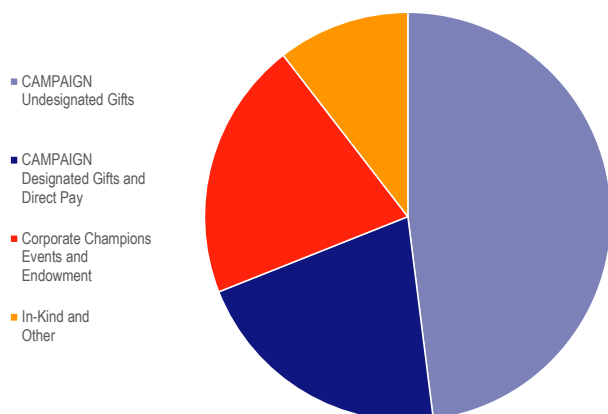

2018-19 FUNDING SOURCES

Corporate Champions cover the majority of administrative and fundraising expenses of the Twin County United Way. This allows more of individual donor dollars to go directly to local programs and services.

Designated and direct pay campaign gifts are dispersed according to specific donor instructions. The Twin County United Way makes it convenient for donors to support their favorite charitable organizations.

Undesignated campaign funds allow the Twin County United Way to leverage donor dollars and provide resources where support is needed most. This is the Community Fund.
